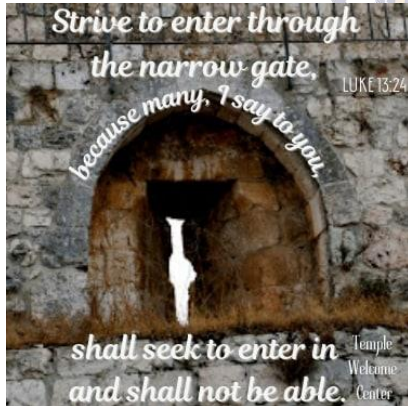

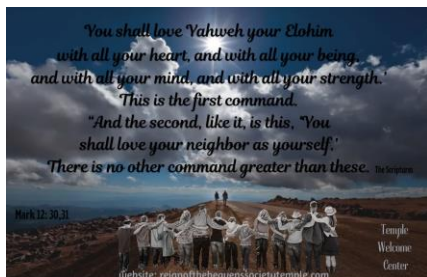
MINUTES OF THE MEETING
